

How to donate to Huaxia Chinese Chorus

Huaxia Chinese Chorus is a Non-profit organization. Donations to **Huaxia Chinese Chorus** are exempt from Federal Income Tax under section 501(c) (3) of the Internal Revenue Code. We do need and appreciate your support for us to bring culture events to this area and better serve the community.

You may donate via the following methods:

A. Donate to Huaxia Chinese Chorus directly

1. Name: **Huaxia Chinese Chorus A NJ Nonprofit Corporation**
2. Tax ID: **20-1366151**
3. Address: **21 Hillside Terr., Livingston, NJ 07039**
4. If your company has a matching fund (it may vary from 50% up to 200%) for donations made to non-profit organizations, please let your company's corresponding department know your intention to donate to **Huaxia Chinese Chorus** and get the procedure. We will work with you to provide with needed documentations.

B. Donate through UNITED WAY

1. When fill the Donor Choice Form, please choose **501 (c) (3)**.
2. Fill the Agency Name as "**Huaxia Chinese Chorus A NJ Nonprofit Corporation**".
3. Fill the Donor Designation as "**Huaxia Chinese Chorus A NJ Nonprofit Corporation**".
4. Huaxia Chinese Chorus' Tax ID is **20-1366151**
5. Huaxia Chinese Chorus' United Way Agency Code is **ZZ114**.
6. Agency Address is **21 Hillside Terr, Livingston, NJ 07039**.
Please make sure you fill in this address. Otherwise, we will not be able to receive the donation.
7. Please give us your name and address. After we received the donation, we will send you the "Thanks You" letter along with the receipt for tax purpose.

C. You may donate goods to Huaxia Chinese Chorus

You are welcome to donate goods such as musical instruments, stage equipments (speakers, mic, music stands), and performance costumes in good condition. Please contact us in advance.

D. You also can donate volunteer time

We greatly appreciate you volunteer your time to help us with our community service activities. Some company has a "community service" program, which donate funds to the non-profit organization their employee volunteered their time. Please contact your company's Community Service Program or Human Resource Department for detailed information. We will provide you with needed documentations.

Questions and Answers

- Q: "Huaxia Chinese Chorus A NJ Nonprofit Corporation" is not on our Donor Designation list, can I still donation to Huaxia Chinese Chorus?
- A: Yes, you still can put "Huaxia Chinese Chorus A NJ Nonprofit Corporation" as the Donor Designation.
- Q: Our company's "Company Match" is only given to certain organizations or organizations in certain counties. Can I donate to Huaxia Chinese Chorus?

- A: Yes, you can still donate to *Huaxia Chinese Chorus*. We may not be able to get your company's matching fund, but we will be able to receive the donation you made through **UNITED WAY**.
- Q: Our company only allows donates made to registered numbers of **UNITED WAY**. How can I donate to *Huaxia Chinese Chorus*?
- A: Any 501 (C)(3) organization can accept donations through **UNITED WAY**. There should be no other restrictions. If your company insists, please do the following:
- a. Ask your company to contact **UNITED WAY** Tri-States Office to confirm that *Huaxia Chinese Chorus A NJ Nonprofit Corporation* is a 501 (C)(3) organization and is eligible to receive donation through **UNITED WAY**.
 - b. If the above method couldn't resolve the problem, please contact *Huaxia Chinese Chorus*, and give us the name of your company's personnel that in charge of this matter, as well as the **UNITED WAY** office they have contact with. We will help to sort things out.
